1. This plan change grid is effective December 1, 2011 for quotes with effective dates beginning January 1, 2012.
2. These rules represent the current practices of Regence BlueShield of Idaho. They can be changed at any time throughout the year without notice.
3. Changes from closed or open plans can only be made to open plans (no changes from closed plans to closed plans).
4. Deductible changes on closed plans are not allowed due to grandfathering rules; members can only move to open plans.
5. Adding dependents to a closed plan is allowed if they meet eligibility requirements.
6. Changes from another BCBS carrier outside of Idaho can only be made to plans that are open to new sales, based on underwriting criteria.
7. Members on HRP plans will require a health statement to move.
8. Regence BlueShield of Idaho does not offer Individual plans in Asotin and Garfield counties; Individual plans in that region are covered by Asuris Northwest Health.
